ADMISSION TO B.Sc. NURSING COURSE on N.R.I. CATEGORY SEATS

Academic Year 2026 - 2027 Prospectus & Instructions to the Applicants

1. Applications for admission to B.Sc. Nursing (Academic year 2026 - 2027) in the 8 NRI category seats at this college is being invited on the basis of this prospectus.
2. The medium of Instruction and examination shall be in English.

University Affiliation

- 3.1 Snehodaya College of Nursing is affiliated to Kerala University of Health Sciences

Prohibition of Ragging

- 4.1 Ragging / any type of misconduct towards any student both in the college campus or outside will be considered as criminal offence and will be immediately reported to the police. Perpetrators will not be permitted to continue their studies.
- 4.2 Every student shall at the time of admission furnish a character certificate from the institute where from he / she has passed the qualifying examination, which would mention the status of his / her behavioural pattern especially in terms as to whether he / she has displayed persistent violent, or aggressive behavior or any desire to harm others.
- 4.3 Students and parents shall, at the time of admission, furnish an affidavit to the effect that the students will not indulge in any form of ragging.

Code of Conduct

- 5.1 Every student is required to adhere strictly to the code of conduct of the institution to which he / she is admitted

Academic Eligibility:

- 6.1 To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the 10 + 2 examination with minimum 80 % of marks under the Kerala State

Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

- 6.2 All applicants must have taken courses in Biology, Physics and Chemistry in addition to English in the High School Years (during their 10th, 11th and 12th). They should have secured minimum 80% marks in Biology, Physics, Chemistry and English at the Plus Two level.
- 6.3 Wherever alphabetical grades like A+, A, B+, B etc. are used by the school, appropriate equivalence in terms of percentage like 100%, 90%, 80% should be made available.
- 6.4 Only students from high schools accredited by the respective State or the country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and **Equivalency Certificate** to this effect shall be produced.

7. How to apply

- 7.1 All applications shall be submitted ONLINE on the website of the College www.snehodaya.com in the following manner.
- 7.2 Before applying on line, a candidate should have:
 - 7.2.1 A valid E mail ID (If you do not have an email address, we recommend Gmail ID)
 - 7.2.2 Scanned copy of the recent passport size colour photograph. Photograph should be taken in a white / light coloured background. The image should be in JPEG Format. Maximum size for photograph 50 KB and image dimension is 120 x 150 px.
- 7.3 Application will be available in the college website (www.snehodaya.com) from 24.07.2026 onwards.
- 7.4 The duly filled application form should be submitted together with self-attested copies of necessary certificates and an application fee of **Rs.2500/- (Rupees Two Thousand and Five Hundred only)**. The Application fee can be paid on line or as DD in favour of **Snehodaya College of Nursing** payable at Irinjalakuda. The filled in applications should reach **Snehodaya College of Nursing, Vallakkunnu, Kallettumkara P.O., Irinjalakuda – 680683 Thrissur, Kerala** not later than **3:00 pm, on 20.08.2026**. The applicants, at their own interest, are advised to send the applications by Speed Post. ***The college cannot be held responsible for non-receipt or late receipt of applications, under any circumstances.*** The application form should be completed carefully; furnishing the entire information called for. Late and incomplete applications and applications not in the prescribed format will be summarily rejected.

Application should be filled by the candidate. Self-attested Photocopies of the following documents shall be attached with the Application (The original documents will have to be submitted at the time of admission).

- a. School Leaving Certificate (S.S.L.C.) of student establishing that the student has completed 17 years of age as on 31.12.2026.
- b. HSE or equivalent examination mark-sheet / pass certificate.
- c. Proof for NRI status (**Refer. no. 11 below**).
- d. A statement to show that the high school in which the student has studied has been accredited by the State/Country/University (**if applicable**).
- e. Equivalence Certificate from Association of Indian Universities (**if applicable**).
- f. Eligibility certificate from Kerala University of Health Sciences (**if applicable**).
- g. A Certificate from the previous institution where the student has studied stating that he / she has not indulged in any kind of ragging during the course of study.
- h. A certificate from the revenue authorities stating that the student belong to the Christian Community.
- i. Physical fitness certificate from the Doctor

Procedure for Selection, Allotment & Admission

8.1 The rank list and selection of all the applicants will be prepared and published on the website on the basis of the total percentage of marks obtained in Physics, Chemistry Biology and English in the Second Year of the Examination – Qualifying Examination. The marks obtained for the qualifying examination will be subjected to normalization process as explained below:

8.2 This process will be done taking into consideration the marks of those candidates who apply pursuant to this prospectus only.

8.2.1 The marks obtained by the students in the relevant subjects in the qualifying examination conducted by various boards or authority shall be equated with the marks obtained by the students in the same subjects in the qualifying examination conducted by the Director of HSE, Kerala, by adopting the method of normalization.

8.2.2 All the Eight NRI seats are reserved for the Christian Community

9 **Age Requirements:** Applicants must be at least 17 years of age on 31st December 2026 (the date of birth being shown on the Matriculation or equivalent certificate).

10 **Eligibility for admission to N.R.I. Category Seats:** According to the GO(MS) No.243/2014/H&FWD dated 06.08.2014, *“An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad”* will only be eligible to apply in the NRI category seats.

11 Copy of the following documents duly attested to prove the NRI status shall be submitted:

- a. Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
- b. Copy of the relevant pages of the passport containing visa details that is attested by the Embassy.
- c. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.
- d. A self affidavit/declaration (*find specimen format Annexure-I*) by the NRI relative (Sponsor) has to be notarised by the Notary Public
- e. Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO(MS) No.243/2014/H&FWD dated 06.08.2014.
- f. Candidates shall produce copies of the sponsor's passport and visa/ Green Card/Overseas Citizenship Card attested by Embassy/Consulate. In the absence of the aforesaid documents attested by Embassy/Consulate, sponsor's passport and visa/Green Card/Overseas Citizenship Card attested by NORKA-ROOTS shall be produced, provided the candidate shall furnish a statement from the sponsor in time, explaining the reason for not getting the documents attested by the respective Embassy/Consulate.

12 FEE STRUCTURE:

The College has given the proposal for the finalization of the Fee Structure, for this admission batch, before the Fee Regulatory Committee. No decision has yet been taken by the Committee. The fees applicable will be as per the order to be passed by the Committee, even if orders are passed after the commencement of admissions. The details of the fees charged for the students admitted last year are given below:

Spot Admission if any, will be intimated if any vacancy arises after the third allotment.

14 Scheme of Admission:

- 14.1 Above mentioned Original documents has to be submitted at the time of admission.
- 15 Candidates who express their intention not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1st year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the College at the time of admission. In the case of students who leave the College midway, the college can collect the liquidated damages.
- 16 All students who get selected should get themselves vaccinated against Hepatitis before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 17 **Ragging is strictly prohibited.** If it is found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.
- 18 Without prejudice to the directions of the Nursing Councils/Government/University, the decision of Snehodaya College of Nursing management shall be final on all matters with regard to admission.
